Article 1 Definitions

In the present general terms and conditions, the following terms are used in the sense given below, unless explicitly indicated otherwise.

Article 2 General

In that event possibly still conflicting stipulations in the seller's and buyer's general terms and conditions shall only apply between parties, if and in so far that they are a part of seller's general terms and conditions.
 4. If one or more stipulations in the present general terms and conditions should be null and void or declared null and void, then the other stipulations of the present general terms and conditions shall termain fully applicable. The case ensuing, seller and buyer shall enter into neonitations to access more new stipulations, realacing the

Article 3 Offers and Tenders

 S. If the acceptance deviates (on secondary items) from the offer given, seller shall not be bound by it. The agreement shall in such event not be concluded in accordance with said deviating acceptance, unless seller indicates otherwise.

 6. A compound quotation shall not oblige seller to execute part of the assignment against a corresponding nart of the niven quotation.

 7. Offers and tenders shall not apply automatically to repeat orders.

Article 4 Execution of the Agreement

- Article 4 Execution of in the Agreement

 1. Seller shall execute the agreement to the best of his knowledge and ability.

 2. The buyer shall see to it that seller shall be provided in due time with all data which user has said to be necessary or which the buyer must in all reasonableness understand to be necessary to the execution of the agreement. If seller has not been provided in due time with the data necessary to the execution of the agreement and / or to charge the buyer for the additional costs resulting from the delay at the generally
- accepted rates.

 3. Seller shall not be liable for damage of whatever nature caused by the fact that seller worked on the basis of incorrect and / or incomplete data provided by the buyer, unless seller should have been aware of said incorrectness or
- 4. If parties have agreed that the agreement will be executed in stages, seller can 4.  5. Buyer shall safeguard user against possible claims filed by third parties who may sustain damage attributable to buyer in connection with the execution of the

Article 5 Delivery

- 1. Delivery shall be made ex works/store/warehouse of seller.

 Buyer shall be held to take delivery of the goods the moment that seller delivers
 them to him or has them delivered, or the moment at which the goods are put at
 buyer's disposal under the agreement.
 If the buyer refuses to take delivery or fails to give the information or instructions
 necessary to the delivery, seller shall be entitled to store the goods at buyer's risk
 and expenses.

 5. If the goods are serviced, seller shall be entitled to charge possible service charges. Said service charges shall then be invoiced separately.

 6. If, in the framework of the execution of the agreement, seller requires data to be
- given by the buyer, the term of delivery shall commence after the buyer has provided seller with said data
- provided seller will said udad.
 7. If seller has given a term of delivery, it shall only be indicative. A given term of delivery shall therefore never constitute a term to be observed on penalty of forfeiture of rights. If a term is exceeded, the buyer must give user notice of default
- in writing.

 8. Seller shall be entitled to deliver the goods in parts, unless such is deviated from in writing in the agreement or if the partial delivery does not represent an independent value. Seller shall be entitled to invoice the thus delivered goods
- separately.

 9. If execution of the agreement in stages has been agreed upon, seller can suspend the execution of the parts belonging to a following stage until the buyer has approved in writing the results of the stage prior to it.

- Article 6 Samples and Models

 1. If a sample or model has been given to buyer, then the assumption is that such has been given by way of indication only, unless parties agree explicitly that the product to be delivered shall correspond with it.

 2. All technical data, samples designs, sketches, drawings, films, software and other material or (electronic) files, deliverded by the seller within the framework of
- the agreement, shall remain seller's property, irrespective of the fact whether they have been handed over to the buyer or to third parties, unless agreed upon
- otherwise in writing.

 In case efforts made by seller do not result in an order from buyer these efforts will

- Article 7 Inspection & Complaints

 1. Buyer shall be held to examine the delivered goods (to have the delivered goods) inspected) the moment of dlivery (handing over), but in any case in as short a period of time as possible. In this respect, buyer must examine whether the quality and the quantity of the delivered goods comply with what was agreed upon, or at least whether they meet the requirements applying to said goods in normal (business) transactions.
- 2 Possible visible shortcomings must be communicated in writing to seller within
- 2. Possible visible shortcomings must be communicated in writing to seller within three days following delivery, Non-visible shortcomings must be reported within three weeks following their detection but no later than 3 months following delivery.
 3. If in accordance with the previous paragraph, buyer files his complaint in due time, he shall still be held to take delivery and effect payment of the goods purchased. It buyer wishes to return defect goods, he shall do so following prior consent in writing from seller.

Article 8 Remuneration, Price and Costs

- I. If seller and buyer have agreed upon an administered price, seller shall nevertheless be entitled to increase said price.
 Seller shall be allowed among others, to charge on price increases if changes in
- 2. Seller shall be allowed among others, to charge on prote increases if changes in price have occurred between the moment the offer was made and the moment of execution of the agreement with respect to, e.g., exchange rates, salaries and wages, raw material, semi-finished products or packaging material.
 3. The prices given by seller shall be exclusive of VAT and other government levies, as well as of the other expenses to be possibly made within the scope of the agreement, including shipment and administration costs, unless stated otherwise.

Article 9 Changes to the agreement

- 1. If it is shown during the execution of the agreement that the work to be done needs to be changed and / or supplemented in order to ensure its proper execution, parties shall adapt the agreement accordingly in due time and in mutual
- If parties agree that the agreement needs to be changed and / or supplemented If parties agree that the agreement needs to be changed and/or supplemented,
 this decision may influence the time of completion of the execution. Seller shall
 inform the buyer thereof as soon as possible.
 Should the change and/or supplement to the agreement have any financial and/
 or qualitative consequences, seller shall inform buyer thereof in advance.
 If a fixed rate has been agreed upon then seller shall indicate the degree to which
 the change or supplement to the agreement will result in an increase of said fixed

- 5. Contrary to the conditions governing this matter, seller shall not be able to charge additional costs if the change or supplement is the result of circumstances attributable to user

- Article 10 Payment

 1. Payment must be made in advance or by crediticard, unless specified otherwise,
 in a way to be indicated by seller and in the currency in which the goods were
 invoiced. Contestation of the amount of the invoices shall not suspend the fulfillment of the payment obligation
- If buyer fails to fulfil his payment obligation in time, then buyer shall be in default by operation of law. In that event, buyer shall owe an interest of 1% per month. unless the statutory interest rate is higher, in which case the statutory interest rate unless the statutory interest rate is higher, in which case the statutory interest rate shall apply. The interest on the amount due and payable shall be calculated as from the day the buyer is in default until the moment he has paid the amount in full.

 3. Seller's claims against buyer shall become due on demand in the event that buyer is wound up, attached, declared bankrupt, or if a suspension of payment is granted.

- 1. All goods delivered by seller, possibly also including designs, sketches, drawings, films, software, (electronic) files, etc., shall remain seller's property until buyer has fulfilled all of his obligations under all agreements concluded with seller.
- Buyer shall not be authorised to pledge or encumber in any way the goods falling

 If third parties seize goods delivered subject to retention of title or wish to establish or assert a right to them, buyer shall be held to inform seller thereof as soon as can reasonably expected.

 The buyer shall undertake to insure the goods delivered subject to retention of title and to keep them insured against damage caused by fire, explosion and water as well as against theft and make this insurance policy available for inspection on
- first demand.
 5. Goods delivered by seller falling under the retention of title by virtue of the stipulations under 1. of the present article, may only be sold on within the framework of normal business activities and must never be used as instrument of
- 6. In the event that seller wishes to exercise his ownership rights mentioned in the O. In the event that senier wisness to execute it is ownership highest network of present article, buyer shall give user or third parties to be appointed by seller, now for then, unconditional and irrevocable permission to access all sites and locations where seller's property might be found and to take these goods back.

- 1. Seller shall guarantee that the goods to be delivered shall meet the usual requirements and standards that can be set for and made upon them and that they
- shall be free of any defect whatsoever.

 2. The guarantee mentioned under 1 shall equally apply if the goods to be delivered
- 2. In eguarantee mentioned under 1 shall equally apply if the goods to be delivered are destined for use abroad and if the buyer explicitly informed seller of this use in writing the moment the agreement was entered into.
 3. The guarantee mentioned under 1 shall be valid for a period of 12 months following delivery.
 4. If the good to be delivered does not comply with said guarantee, seller shall, at his discretion, replace or see to the repair of the good, within a reasonable period of time following receipt thereof, or, if the good cannot be returned in reason, following motification of the defect but he typuer In the event the good is. notification of the defect by the buyer. In the event the good is replaced, the buyer shall already now undertake to return the replaced good to seller and to transfer ownership to seller.
- UNIVESTABLE USE AT SET A STATE OF THE PROPERTY OF THE PROPERTY
- for lifting guarantee given by seller concerns a good produced by a third party, the guarantee shall be limited to the guarantee given by the producer of the good.

Aticle 13 Collection Charges

- 1. If the buyer fails to fulfil his obligations (in due time) or defaults on them, then all 1. If the buyer fails to fulfil his obligations (in due time) or netatils on timer, then air reasonable costs incurred to have all extrajudicial costs and debts paid shall be borne by the buyer. If the buyer remains in default of payment within the set time period, he forfeits a immediately payable fine of 15% on the amount due at that moment. This with a minimum of 50.

 2. If seller demonstrates that he has incurred higher expenses, which were necessary in reason, said expenses shall also qualify for reimbursement.

 3. The reasonable judicial and execution costs possibly incurred shall equally be home by briune;

Article 14 Suspension and Dissolution

- Seller shall be authorised to suspend the fulfilment of the obligations under the agreement or to dissolve the agreement, in the event that:
- buyer does not fulfil or does not fully fulfil his obligations resulting from the
- agreement

 after the agreement has been concluded, seller learns of circumstances giving good ground to fear that the buyer will not fulfill his obligations. If good ground exists to fear that the buyer will only partially or improperly fulfil his obligations, suspension shall only be allowed in so far the shortcoming justifies such action.

 Liver was expected to furnish exempt to nursariathe the fulfillment of his obligations.
- buyer was asked to furnish security to guarantee the fulfilment of his obligations resulting from the agreement when the contract was concluded and that this security is not provided or insufficient. As soon as security is furnished, the authorisation to suspend shall lapse, unless said fulfilment has been unreasonably
- authorisation to suspend shall lapse, unless said fulfilment has been unreasonably delayed because of it.

 2. Seller shall furthermore be authorised to dissolve the agreement (have the agreement dissolved) if circumstances arise of such a nature that fulfilment of the obligations becomes impossible or can no longer be demanded in accordance with the requirements of reasonableness and fairness, or if other circumstances arise of such a nature that the unaltered maintenance of the agreement can no longer be demanded in all reasonableness.

3. If the agreement is dissolved, the seller's claims against the buyer shall be forthwith due and payable. If seller suspends fulfilment of his obligations, he shall retain his rights under the law and the agreement.

Seller shall always retain the right to claim damages.

Article 15 Return of Goods Put at Buver's Disposal

 If seller has put goods at buyer's disposal during and in connection with the execution of the agreement, buyer shall be held to return the delivered goods within 14 days in their original state, free of defects and in their entirety. If buyer fails to fulfil this obligation, all resulting costs shall be at buyer's expense.

 2. If, for any reason whatsoever, buyer still remains in default to fulfil the obligation mentioned under 1. after being warned to do so, seller shall be entitled to recover
- the resulting damage and costs, including replacement costs, from buyer,

Article 16 Liability

- If the goods delivered by seller are defective, user's liability vis à vis the buyer shall be limited to the arrangements made in the present terms and conditions

 2. If seller is liable for direct damage, then said liability shall be limited to a maximum of the value stated on sellers invoice. Seller's liability shall at all times be limited to a maximum equalling the amount of the payment to be made by seller's
- insurer in the occurring event.

 3. Seller shall never be liable for indirect damage, including consequential damage, loss of profit, lost savings and damage due to business stagnation.

Article 17 Transfer of Risk

1. The risk of loss of, or damage to the products being the subject of the agreement, shall be transferred to buyer the moment said products are judicially and/or actually delivered to buyer and therefore fall into the power of buyer or of third parties to be

- Article 18 Force Majeure
 1. Parties shall not be held to fulfil any of their obligations if they are hindered to do so due to a circumstance through no fault of their own and which cannot be attributed to them by virtue of law, a legal action or generally accepted practice.
- 2. In addition to the provisions of the law and the judge-made law in this respect. 2. In addition to the provisions of the law and the judge-made law in this respect, force majeure shall in the present general terms and conditions furthermore be understood to be any external circumstance, be it envisaged or not, on which seller cannot have any influence but which prevents seller from fulfilling his obligations. Industrial action at sellers company shall also be understood to be a circumstance offorce majeure.
 3. Seller shall also be entitled to invoke force majeure if the circumstance rendering.
- (further) fulfiliment of the obligation(s) impossible, commences after the point in time on which seller should have fulfilled his obligation.

 4. Throughout the duration of the circumstances of force majeure, parties shall be
- entitled to suspend the fulfilment of their obligations. If this period lasts for more

 5. Insofar seller has already partially fulfilled his obligations resulting from the agreement at the moment the circumstance of force majeure commenced or shall be able to fulfill them and insofar separate value can be attributed to the part already fulfilled or still to be fulfilled respectively, seller shall be entitled to invoice the part already fulfilled or still to be fulfilled respectively. The buyer shall be held to pay this invoice as if it were a separate agreement.

Article 19 Safeguarding

- Article 20 Intellectual Property and Copyrights

 1. Without prejudice to the other stipulations of the present general terms and conditions, seller shall reserve the rights and authorities to which user is entitled under the Copyright Act.
- The buyer shall not be allowed to introduce changes to the goods and material
- 2. The buyer shall not be allowed to introduce changes to the goods and material provided, unless the nature of the delivered goods and material dictates otherwise or if agreed upon otherwise in writing.
 3. The designs, sketches, drawings, films, software and other material or electronic) files, possibly produced by the seller within the framework of the agreement, shall remain seller's property, irrespective of the fact whether they have been handed over to the buyer or to third parties, unless agreed upon otherwise in writing.
- All documents, such as designs, sketches, drawings, films, software. (electronic) files, etc., provided by seller, shall be destined to be used by buyer exclusively and must not be reproduced, made public or brought to the notice of third parties by buyer without prior consent from seller, unless the nature of the
- documents provided dictates otherwise.

 5. Seller shall reserve the right to use the knowledge gained due to the execution of the work for other purposes, in so far no confidential information shall be brought to the notice of third parties when doing so.

- Both parties shall be bound to secrecy of all confidential information they have received within the scope of their agreement from each other or from another source. Information shall be considered to be confidential if the other party has indicated so or if the confidential character results from the nature of the
- 2 If a statutory provision or a judicial decision compels user to convey confidential 2. If a statutory provision or a judicial decision compels user to convey confidential information to third parties designated by law or by the court and seller cannot for that purpose invoke a legal right to refuse to give evidence or such a right acknowledged or allowed by the competent court, seller shall not be held to pay damages or compensation and the opposite party shall not be entitled to demand the dissolution of the agreement on the ground of any damage resulting from said

Article 22 Technical assistence

 Unless otherwise expressly stated by seller: 1 any technical advice provided by Is offices officed in the goods furnished to buyer shall be without charge, 2 selfer with respect to the goods furnished to buyer shall be without charge, 2 selfer assumes no obligation or liability for any such advice, or for any results occurring as a result of the application of such advice; and 3 buyer shall have sole responsibility for selection and specification of the goods appropriate for the end

Article 23 Disputes

- The Court in seller's place of business shall have exclusive jurisdiction to hear actions, unless the District Court is the competent Court. Seller shall nevertheless be entitled to submit the dispute to the Court deemed competent by the law.
- 2. Parties shall only refer the matter to the court if they have done their utmost to solve the dispute in mutual consultations.

Article 24 Applicable Law

1. Dutch law shall apply to each and every agreement between seller and the buyer. The Vienna Sales Convention shall be explicitly excluded.

Article 25 Changes to the Terms and Conditions, interpretation and their
